PROFIT WARNING

This announcement is made by True Partner Capital Holding Limited (the “**Company**”, together with its subsidiaries, the “**Group**”) pursuant to Rule 17.10(2) of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited (the “**GEM Listing Rules**”) and the Inside Information Provisions (as defined in GEM Listing Rules) under Part XIVA of the Securities and Futures Ordinance (Chapter 571 of the Laws of Hong Kong).

The board (the “**Board**”) of directors (the “**Directors**”) of the Company would like to inform the shareholders of the Company (the “**Shareholders**”) and potential investors that based on the preliminary review and assessment of the unaudited consolidated management accounts of the Group for the year ended 31 December 2023 and other information currently available to the Board, the Group is expected to record a net loss attributable to owners of the Company for the year ended 31 December 2023 in the range of approximately HK\$60 million to HK\$73 million as compared to a net loss attributable to owners of the Company of HK\$33.6 million for the year ended 31 December 2022.

Based on the information currently available to the Company, the Board believes that the estimated loss for the year ended 31 December 2023 was mainly attributed to a decrease in revenue, from HK\$44.8 million in the year ended 31 December 2022 to HK\$13.3 million. Comparing the year ended 31 December 2023 to year ended 31 December 2022, overall assets under management (the “**AUM**”, Note 1) declined as detailed in our regular monthly filings and there were changes in underlying product mix. The changes in AUM primarily reflected factors including idiosyncratic changes with some underlying clients, as well as the effects of a challenging trading environment in general. Overall, the effects of the changes in AUM and product mix also included that the

expected relative contribution of management fees and performance fees to revenues per unit of AUM became more focused on performance fees and less focused on management fees. The combination of these factors led to a decrease in the average revenue per unit of AUM for the year ended 31 December 2023 as compared to the year ended 31 December 2022. In combination, these factors also led to a decrease in overall revenues for the year ended 31 December 2023 as compared to the year ended 31 December 2022.

Note 1: The AUM of the Group is prepared on the basis that AUM figures are recalculated as at the last dealing date of the previous month reported by the administrator or custodian of each fund/managed account, which date may or may not be the last business day of the year/period. In line with the general market practice, subscriptions and redemptions on the last dealing date are not taken into account in arriving at the AUM figures.

The Company is in the process of finalising the results of the Group for the year ended 31 December 2023. The information contained in this announcement is only based on a preliminary assessment by the Board of the unaudited consolidated management accounts of the Group and the information currently available to the Company and is not based on any figures or information that have been audited or reviewed by the Company's auditors. The figures contained in this announcement may be subject to adjustment based on updated information. Details of the Group's results will be disclosed as and when the yearly results of the Group for the year ended 31 December 2023 is announced, currently expected to be on 26 March 2024.

The Shareholders of the Company and potential investors are advised to exercise caution when dealing in the shares of the Company.
