VOLUNTARY ANNOUNCEMENT BUSINESS UPDATE

This announcement is made by True Partner Capital Holding Limited (the “**Company**”, together with its subsidiaries, collectively the “**Group**”) on a voluntary basis to provide the shareholders (the “**Shareholders**”) and potential investors of the Company with an update on the latest business development of the Group.

BUSINESS UPDATE

The board (the “**Board**”) of directors (the “**Directors**”) of the Company is pleased to announce that as at the date of this announcement, the Group has commenced autonomous mobile-robot sales (the “**Mobile-Robot Business**”) and is targeting to customers across the Benelux region (Belgium, the Netherlands and Luxembourg) and key Southeast Asian markets (Hong Kong, Singapore, Malaysia, Thailand, Indonesia and Philippines). The Mobile-Robot Business delivers high performance robotics from established Chinese manufacturers combined with a locally based service layer that emphasises data governance, regulatory compliance, and end to end consultancy. As at the date of this announcement, the Mobile-Robot Business is available to enterprises and professional organisations seeking to enhance their operations in the selected Southeast Asian markets. The Group expects that the Mobile-Robot Business will be available to the Benelux market in or around July 2026.

While the Group explores expansion into the Mobile-Robot Business to broaden its sources of revenue, it will continue to operate its existing principal businesses of asset management and consultancy services. To date, the Group continues active engagement with prospective clients for its investment strategies and other customised solutions with a view to replenish and grow its assets under management.

The Board considers that the commencement of the Mobile-Robot Business is in line with the Group's overall direction of expanding its business scope and enhancing business sustainability. The Company has been actively exploring new business opportunities and possibilities with a view to delivering greater returns to its Shareholders, which is in the interests of the Company and its Shareholders as a whole. The Group will make announcements on its development progress in accordance with the requirements of the Rules Governing the Listing of Securities on GEM of The Stock Exchange of Hong Kong Limited as and when appropriate.

The publication of this announcement is to provide updated information on the business development of the Group to the Shareholders and potential investors of the Company. The Company wishes to emphasise that, as at the date of this announcement, it has not entered into any formal or legally binding agreement concerning the Mobile-Robot Business. Shareholders and potential investors of the Company are advised to exercise caution when dealing in the securities of the Company.
